I understand that my dog will be playing with many other dogs and thereby exposed to normal hazards of community play (cuts, scratches, etc.) and I agree that Dog Townsend may seek emergency treatment for my dog**, and I agree to assume all medical expenses.

Dog Townsend, Inc. screens for issues of anxiety, however in the event that a dog becomes extremely anxious, Dog Townsend, Inc. may administer a proper dose of a tranquilizer for the safety of the dog, the other dogs, the staff, or the kennel's well-being (excessive barking/howling) This will only be done in extreme cases. We always try other means of calming first.

*Bordetella is a canine respiratory illness somewhat similar to the flu. There are many strains of Bordetella. Dogs are particularly susceptible when under any kind of stress, like being away from family. Thus the nickname "Kennel Cough". Vaccines offered by vets cover most but not all forms of Bordetella.

Bordetella Waiver: I understand that my dog can contract Bordetella even if s/he has been vaccinated and I will not hold Dog Townsend, Inc. or any of their employees or clients responsible in the event that my dog becomes ill._____ (Sign)

****Injury and/or illness policy:**

Small cuts, sore paws, scratches, minor tummy issues, etc. are treated with a time out and notification of owner upon pick up. More serious issues such as choking, poor breathing, serious cuts, possible broken bones, prolonged diarrhea, vomiting etc. are an immediate trip to the vet. (Owner assumes any and all expenses.) We will try to bring your dog to YOUR vet, but if they are closed or unable to help right away we will bring her/him to the nearest available emergency veterinary service. We will make every effort to contact you as soon as reasonably possible in the event of any serious health concerns.

Escape policy: Dog Townsend, Inc. maintains fences at least 5-6' tall. We pre-screen and turn away dogs that attempt to escape during the trial or thereafter. If your dog *does* escape we will do everything we can to retrieve her/him. Dog Townsend, Inc. will not be held liable for any loss or damage from escape or theft.

No aggression tolerance policy: I understand that Dog Townsend, Inc. is not equipped to care for or board any dog which is aggressive to other dogs or to people and that Dog Townsend, Inc. reserves the right to refuse service to any dog at any time._____ (Sign)
